Applicant needs to select the correct Project Assistant/Associate Level for particular position while filling the online form.
- After online submission of application form (**Last Date: 10th November 2021**), the applicants are requested to note down their application number. The applicant needs to send the hard copy of the online generated application form in PDF format along with the self – attested scanned copies of original documents viz., (a). Educational qualification (b) Age proof (c) Proof of Experience through Speed Post/Courier by **16th November, 2021 to Scientist & Head, CSIR-NEERI, Mumbai Zonal Center, 89/B, Dr. Annie Besant Road, Worli, Mumbai- 400018.**

P.S.: Applicant must paste a passport size photograph on the hard copy of application form.

- Only those candidates who have completed the essential qualification & result has been declared are eligible to apply
- The applications shall be scrutinized by the screening committee. Any discrepancy/ error found in the application form will disqualify the candidature. The short-listed candidates shall be intimated by e-mail. The short-listed candidates shall be required to appear for virtual interview. Date of interview, Interview link and timings shall be communicated to the shortlisted candidates in advance. It is the responsibility of the applicant to check the email inbox and other email folders, regularly. The shortlisted candidates have to be available on the date of interview from 10 A.M. onwards and will be called anytime during the allotted time period. (if any change is there, they will be accordingly intimated)
- All manpower positions in the projects are on contract basis and will be co-terminus with the project.
